The primary purpose of group counseling notes is to help the client and keep track of his or her progress toward meeting treatment goals 1. Group Notes: This type of note is entered into an Encounter Note. All treatment group notes must be in DAP format. Information recorded must include a summary of what happened in group. The Group note is to be completed within the same business day as the group was held (or last group held in a work week for Residential/Halfway House group notes.)

Progress Notes Procedure - ASAC

To help therapists and assistants improve their documentation, the following are examples of documentation that clearly demonstrates the skilled nature of therapeutic exercise. (Skilled terminology is highlighted in red.) 1. Patient arrived at therapy with 3/10 L hip pain.

PT/OT Skilled Therapeutic Exercise Documentation Examples ...

Each note should tell a story about your patient, and your subjective portion should set the stage. Try to open your note with feedback from the patient about what is and isn't working about their therapy sessions and home exercise program. For example, you can say any of the following to get your note started:

Summary of the diagnosis, functional status, symptoms and the progress to the current. The perfect examples of progress notes are SOAP. A SOAP note consists of four sections, namely: Subjective, Objective, Assessment and Plan. Each of these sections is employed for assessing the problems of the patient and furnishing him with a form of treatment.
